Course Description

What is this Course about?

This course will look into a pantheon of interdisciplinary thinkers such as Jung, Weber, and Geertz to analyze salient theories about the patterns and paradoxes of sacred experiences across religions. We will explore how communities from various times and geographies express their sacred experiences through symbols, myths, scriptures, time, and space and how these are accessed and transformed through diverse interpretations. Our fundamental aim will be to discover the intrinsic connection between the sacred and our notions of self, nature, society, reality, and so on.

Ultimately, this course will prepare you to formulate your own theoretical questions and methodology to create and apply new knowledge in any field of study. It will also provide you with the necessary tools to guide your individual quest. Welcome!

Why Should I Care about Religion?

Why do I struggle to lead a meaningful life? How do I determine what makes life worth it in the face of suffering and evil? Is religion irrelevant in our fast-paced technological world? Does the sacred look the same across traditions? Is religion a creative or destructive force? These are just some of the questions that we will explore throughout the semester.

This course is interested in examining the different expressions, practices and interpretations of religion from an interdisciplinary perspective. Although no particular religion will be favored, materials from several religions will be chosen to exemplify thematic topics in the experience of the Sacred. We will also focus on the tenets of religions, dispelling common misconceptions and assumptions and looking into the emergence of new practices among the post-denominational generation.

How can this course help you advance in your career?

You do not need to be personally religious, majoring in religious studies, or in a field within humanities to benefit from this course. Whatever your academic field is, this course will train you to make important connections between your career and the world of the sacred and the profane. You will be able to understand the complexity of the definitions of religion and secularization, and the role religion plays in local and international affairs.

Religious illiteracy can greatly impact our ability to understand personal and social motivations behind financial decisions, political engagement, science and technological advancement, environmental and migration policies, family planning, diet and food production, gender relations, war and terrorist attacks, and more. Whether you notice or not, religion is a universal phenomenon that continues to transform and be transformed by our societies. Religion greatly influences one's epistemology, or the way they deal with what is true or false, as well as the way they look at the world. If we fail to understand religion & secularization, we may fail to understand people.

Our approach is interdisciplinary, which means you will be critically reflecting from many fields of study such as philosophy, psychology, cultural studies, history, economics, gender studies, among others. This enhances your ability to think critically, communicate effectively, respond sensitively, collaborate with others and creatively resolve conflict.

Student Learning Outcomes/Objectives

- 1. Identify key thinkers such as Jung, Durkheim, and Weber and their interdisciplinary theories about the patterns and paradoxes of sacred experiences across traditions
- 2. Classify and utilize various approaches to the study of religion, including but not limited to ethnographic, psychological, sociological, ethical, phenomenological, and so on.
- 3. Compare and contrast the key underlying beliefs and principles of many religions.
- 4. Demonstrate knowledge of the evolution and movement of religious beliefs from ancient to contemporary times.
- 5. Speak intelligently about the relationship between religion and other cultural phenomena such as art, literature, music, film, and so on.
- 6. Demonstrate an increased empathetic awareness of religious diversity and differences.
- 7. Correctly distinguish between primary vs secondary sources, insider/ideological vs outsider/academic sources, and scholarly vs journalistic sources.

Expectations of this Course

Statement on Plagiarism

No assignments will be accepted after the last day of in person class with the exception of the final exam. No exceptions.

Assignments & Assessments

As this is a Gordon Rule course, students will be required to write a minimum of two major assignments. **The essays must have a thesis (topic/original research), and adequately support that thesis. The essays must be organized clearly and logically.** Each paper will be 1,200 words and will be submitted through Turnitin. All source material must be cited correctly using Chicago or MLA style formatting. Please be aware that papers with an originality score of over 35% similarity and/or AI will be subject to additional scrutiny and may incur additional penalties, up to and including receiving an F (0 points). **Please DO NOT send any writing assignments as email or message attachments! All writing assignments must be submitted in the proper drop box in Canvas; there are no exceptions.** Late papers may be accepted with a legitimate excuse and the maximum score will be 90%.

1. Discussions:

Description: Throughout the semester, you will participate in six discussions. Each discussion will focus on specific questions related to the course topics. You are expected to post thoughtful responses and actively engage with the reading material and class discussions. Some discussions will be conducted in class using paper and pen, in response to various topics covered in lectures.

Due Dates: Discussions will be assigned randomly at the beginning of the week on Tuesday. Posts are due the following Monday at 11:59 pm. Late submissions will incur a 10% deduction in points.

Submission: Post your responses directly to the designated Canvas discussion board (Modules) It will also appear in your assignments as a reminder.

Evaluation Criteria: Discussions will be evaluated based on clarity of writing, depth of analysis, engagement with course material, and quality of peer responses.

A rubric will be provided.

Extra Points: If you participate in all six discussions, you will earn extra points (5%). If you only complete five discussions, points deductions will not be made (one freebie).

Video Comments: Some modules will include videos related to course topics. You are required to watch these videos and comment according to the instructor's requirements, which will be outlined in each module. Comments will be evaluated based on relevance to the video content, depth of analysis, and engagement with the material. Specific criteria will be provided for each video.

1. ESSAY #1

Religious Site Visit Essay / MIDTERM (1200 words).

- **Description:** This essay requires field research, where you will attend a religious service. You must visit a religious site from a tradition different from your own and write a report on your experience. The goal is to immerse yourself in and analyze an unfamiliar religious context or tradition. Your essay should offer a detailed account of your findings and reflections, addressing the aspects outlined in the course materials. Your paper must include a clear thesis statement. Detailed instructions and formatting guidelines are provided in the course materials. You will have the opportunity to revise your essay. Please be aware that plagiarism is a serious offense; any instances of plagiarism will result in a failing grade for the course. To complete this assignment, you must select a religious site and provide proof of your visit. If you attend a

physical service, a photograph of yourself at the site will be sufficient. If you attend an online service, please provide the following details: the name of the site or church, the title of the sermon, and the hour of the service (include the link).

- **First Draft:** You must submit a 1,200-word first draft. The purpose of this first draft is to give you feedback and make you a better writer. You need to submit a picture of yourself at the site for credit. **Please attach photo to submission at end of word doc.**
- **Final Draft:** After my feedback on first draft the final draft must be at least 1,200 words long and cover 3 elements of the religion or site you are visiting. Please submit a picture of yourself at the site for credit. Please attach photo to submission at end of word doc.
- **Submission:** Submit your essay as a Canvas Assignment. **Please DO NOT send any writing assignments as email or message attachments.** Late submissions will not be accepted unless approved by the instructor, and the maximum grade for late submissions will be 90%.
- **Evaluation Criteria:** Essays will be evaluated based on the depth of observation, insightfulness of analysis, clarity of writing, and adherence to academic standards. A rubric will be provided.

ESSAY #2

Final Project (Personal Analysis):

Description:

For your final project, you will choose a topic from the course material, such as "Ways to Study Religion," "What is Religion," "Sacred Symbols," or "Myth and Doctrine." Your project should include a comprehensive description of common aspects of religion, including myth, ritual, sacred texts, divinities/prophets/enlightened beings, paths to liberation, views on righteousness and sin, and interpretations of gender, violence, and purity. In this essay, you will analyze your own experiences using the theoretical frameworks introduced in this class. The objective is to assess your understanding of core concepts in the study of religion by identifying what is sacred in your life and presenting this as your thesis. Support your thesis by describing and defending the significance of your chosen sacred value, especially in relation to themes of suffering, evil, and the human condition. **The first draft of your project in Week 13. The final draft is due on Canvas in Week 15.** Alongside with this essay, you will have a presentation in class during the final's week. Prepare a PowerPoint presentation and a 1200-word essay on your chosen topic. Your presentation should be approximately 15 to 20 minutes long. Your grade will be based on both your PowerPoint presentation and your essay.

Submission: Submit the PowerPoint presentation and essay via Canvas. You will present your project in class during the final week.

- **Evaluation Criteria:** The project will be graded based on the following:

PowerPoint Presentation: Clarity, organization, visual appeal, and how well it complements your essay.

Essay (1200 words): Depth of analysis, clarity of writing, and adherence to academic standards (150 points).

Presentation: Effectiveness in communicating ideas, engagement with the audience, and overall delivery.

Extra Credit Opportunities

You have the chance to earn up to 5% of your final grade through one extra credit opportunity. All submissions must be made through Canvas; emails will not be accepted.

1. Visit the Writing Center: Earn 5% extra credit by visiting the Writing Center for assistance with one of your essays. Schedule your appointment early, attend it, and work with the staff to improve your writing. After your session, the Writing Center will provide a confirmation email of your completed appointment. Take a screenshot of this confirmation and upload it to Canvas under the "Extra Credit- Writing Center" category.

2. Participate in an Additional Discussion: Although only five discussions are required, you can complete a sixth one for up to 5% extra credit towards your discussion grade.
